



NHRTL-PAC '22 NH PRIMARY VOTING GUIDE

NH Right to Life Political Action Committee (NHRTL PAC) makes available this 2022 NH Primary Voting Guide to assist life-minded voters in choosing candidates for the state offices of Governor, Executive Councilor, State Senator, and State Representative.

NHRTL PAC urges conscientious pro-lifers to support the below candidates on Primary Day **Tuesday, September 13.**

Recommendations are either:

- **Endorsed:** NHRTL-PAC's highest recommendation. A candidate has affirmed that they are strongly pro-life through a survey or voting record. We believe endorsed candidates will defend all human life without exception.
- **Supported:** candidates that we didn't endorse who we believe would be the most life-affirming choice in a *particular* race. Note that this depends heavily on the context of the race and could mean that a candidate is strongly pro-life or that they simply don't openly advocate for abortion.

Information used in this voter guide came from various sources, including a survey conducted by NHRTL PAC, voting records (where available), and public statements. Only a candidate's views on protecting life were considered.
