

NHRTL-PAC '24 NH PRIMARY VOTING GUIDE

NH Right to Life Political Action Committee (NHRTL PAC) makes available this 2024 NH Primary Voting Guide to assist life-minded voters in choosing candidates for the state offices of Governor, Executive Councilor, State Senator, and State Representative.

NHRTL PAC urges conscientious pro-lifers to support the below candidates on Primary Day Tuesday, September 10.

Recommendations are:

- Endorsed: <u>NHRTL-PAC's highest recommendation</u>. A candidate has affirmed that they are strongly pro-life through a survey or voting record. <u>We believe endorsed candidates</u> will defend all human life without exception.
- **Supported:** candidates that we didn't endorse, but who we believe would <u>be the most</u> <u>life-affirming choice in a *particular* race</u>. Note that this depends heavily on the context of the race and could mean that a candidate is strongly pro-life or that they simply don't openly advocate for abortion or assisted suicide.
- **Opposed:** candidates who want to legalize the aborting of children at 7, 8, and 9 months by seeking to repeal the Fetal Life Protection Act (which protects children at 6 months/24 weeks or otherwise negate its protections (e.g. Constitutional Amendment proposals CACR23 and CACR24)

Information used in this voter guide came from various sources, including a survey conducted by NHRTL PAC, voting records (where available), and public statements. Only a candidate's views on protecting life were considered.

Only candidates in contested primaries are included here to save space. Candidates for whom we have insufficient information and those whom we do not support, endorse, or oppose are also omitted. STATE REPRESENTATIVES (DEMOCRATIC PRIMARY)

Note: Every incumbent Democratic State Representative who has voted on the issue, voted to legalize the aborting of 7, 8, and 9 month children (2023 HB224, HB271, or 2024 CACR23). CACR23 could have even legalized forced abortions according to a former Chief Justice of the NH Supreme Court.

While CACR23 had a provision that only allowed abortions past 24 weeks if needed in the opinion of a physician, the protection effectively allowed abortions at any time since several abortionists have stated that abortion should always be an option.
